



Policy: Board Member Term Rotation

A term of office is 3 years. Board members may serve only 2 consecutive full terms in a position. Terms are rotated so a new President, Past President, and Reporter begin service in year 1; a new Vice President, Treasurer, and Member 1 begin service in year 2; and a new Secretary, Member 2, and Member 3 begin service in year 3. The logical progression of office is from Vice President to President to Past President, but this progression is not mandatory. Term rotations prevent our Board of Directors from being disadvantaged by all new members at the same time. Returning board members should orient, assist, and mentor new board members.
